Commissioner Valdez made a motion to hire a civil engineer at a cost not to exceed \$ 10,000.00 to design the proper water drainage plan away from the fire station. - 7. Authorize the transfer of \$ 100,000.00 from ESD No. 2 into the D2FR operating account. Commissioner Ruiz made a motion to authorize the transfer of the funds. Commissioner Lemanski seconded the motion. Motion carried by a 5/0 vote in favor of.
- 8. Authorize the transfer of \$ 10,000.00 from the D2FR operating account into the D2FR payroll account. Commissioner Lemanski made a motion to

authorize the transfer of the funds into the payroll account. Commissioner Ruiz seconded the motion. Motion carried by a 5/0 vote in favor of.

9. Adjourn. Commissioner Ruiz made a motion to adjourn. Commissioner Brown seconded the motion. Motion carried by a 5/0 vote in favor of. Meeting was adjourned at 7:24 P.M.
