- 2. The Pledge of Allegiance. The Pledge of Allegiance was recited.
- 3. Citizens Public Forum (Individuals will have 3 minutes to address the Board.) There were no requests for citizens public forum.

 - a. Architectural Services A motion was made by Christopher Rait to approve the architect Brown, Reynolds Watford to acquire the services of Septic Systems Express to design a septic system and obtain necessary permits for Station 124 at a cost of \$3,500. A second to the motion was made Brian Fite. The motion carried with 3-Aye and 0-Ney.
 - b. Construction A motion was made by Christopher Rait to authorize Josh Brown to approve the cost for advertisement in the newspaper for the bidding of Station 124. A second to the motion was made by Brian Fite. The motion carried with 3-Aye and 0-Ney.
 - c. Financing There was no action taken on this item.
 - d. Temporary Facilities A motion was made by Christopher Rait to purchase a facility from Palomar Buildings at a HGAC proposal cost of \$274,937 to include building, fire alarm option, delivery, ramps and steps. A second to the motion was made by David Harris. The motion carried with 3-Aye and 0-Ney.
- 7. Deliberation, updates and/or action regarding the following financial items:
 - a. Financial Reports
 - b. Cash Reconciliations
 - c. Investment Reports
 - d. Authorization to pay/ratify monthly bills due/paid
