The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for BEXAR COUNTY BEXAR COUNTY EMERGENCY SERVICES DISTRICT NO. 2 from the same properties in both the 2021 tax year and the 2022 tax year.

The voter-approval rate is the highest tax rate that BEXAR COUNTY EMERGENCY SERVICES DISTRICT NO. 2 may adopt without holding an election to seek voter approval of the rate for BEXAR COUNTY EMERGENCY SERVICES DISTRICT NO. 2.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that BEXAR COUNTY EMERGENCY SERVICES DISTRICT NO. 2 is proposing to increase property taxes for the 2022 tax year.

A PUBLIC MEETING ON THE APPROVAL AND ADOPTION OF A TAX RATE WILL BE HELD ON AUGUST 25, 2022, AT 7:00 PM OR IMMEDIATELY FOLLOWING THE CONCLUSION OF THE PUBLIC HEARING AND WILL BE LOCATED AT 14515 OMICRON DRIVE, SAN ANTONIO, TX 78245.

The proposed tax rate is greater is not greater than the voter-approved tax rate and does not exceed the rate that allows voters to petition for an election under Section 26.075, Tax Code. If BEXAR COUNTY EMERGENCY SERVICES DISTRICT NO. 2 adopts the proposed tax rate, the BEXAR COUNTY EMERGENCY SERVICES DISTRICT NO. 2 is not required to hold an election so that voters may accept or reject the proposed tax rate and the qualified voters of the BEXAR COUNTY EMERGENCY SERVICES DISTRICT NO. 2 may not petition the BEXAR COUNTY EMERGENCY SERVICES DISTRICT NO. 2 to require an election to be held to determine whether to reduce the proposed tax rate.

YOUR TAXES OWED UNDER ANY OF THE RATES MENTIONED ABOVE CAN BE CALCULATED AS FOLLOWS:

The 86th Texas Legislature modified the manner in which the voter-approval tax rate is calculated to limit the rate of growth of property taxes in the state.
