PUBLIC HEARING AND MEETING MINUTES September 16, 2025

Bexar County Emergency Services District No. 2 conducted a public hearing and meeting in the Bexar County Emergency Services District No. 2 Meeting Room located at 14515 Omicron Drive, San Antonio, TX 78245, to discuss the following:

- 1. Call the Bexar County Emergency Services District No. 2 public hearing on the 2025 ad valorem tax rate to order and establish a quorum.** – *Commissioner Harris called the public hearing to order at 6:05 PM (18:05). A quorum was established with Commissioner Harris, Commissioner Almanza, and Commissioner Bradley present. Commissioner Cash and Commissioner Rait were absent.*
- 2. Citizens' Public Comment on the 2025 ad valorem tax rate (Speakers will be limited to three (3) minutes to address the Board. The Board will not comment or engage in discussion.)** – *There were no requests for Citizens' Public Comment.*
- 3. Adjourn the public hearing.** – *Commissioner Almanza motioned to adjourn the meeting at 6:23 PM (18:23), with a second from Commissioner Bradley. The motion carried with 3-Aye and 0-Ney.*
- 4. Call the Bexar County Emergency Services District No. 2 meeting to order and establish a quorum.** – *Commissioner Harris called the meeting to order at 6:23 PM (18:23). A quorum was established with Commissioner Harris, Commissioner Almanza, and Commissioner Bradley present. Commissioner Cash and Commissioner Rait were absent.*

Deliberation, update, and action regarding adopting a 2025 ad valorem tax rate, resolution of such, and any related matter.** – *Commissioner Harris motioned to waive the reading and adopt resolution 20250916-001, setting the 2025 adopted tax rate at \$0.087932 per \$100 of valuation, with a second from Commissioner Almanza. The motion carried with 3-Aye and 0-Ney.*
- 6. Deliberation, update, and action regarding the election of Bexar County Emergency Services District No. 2 Commissioners to officer positions on the board.** – *There was no action taken on item 6.*
- 7. Deliberation, update, and action regarding the Bexar County Emergency Services Districts Association, including but not limited to selection of primary and alternate ESD2 representatives to the Association.** – *There was no action taken on item 7.*
- 8. Determine the next meeting's date, time, and agenda items.** – *September 25, 2025, at 6:00 PM (18:00).*
- 9. Adjourn.** – *Commissioner Almanza motioned to adjourn the meeting at 6:34 PM (18:34), with a second from Commissioner Harris. The motion carried with 3-Aye and 0-Ney.*
